Opening Remarks

1. <u>The Chairman</u> welcomed all to the meeting and apologised for the short notice of the meeting. He introduced Government Representatives to the forum.

Purpose of Meeting

2. The Chairman informed the meeting that Government would introduce legislation with a view to prohibiting inappropriate level of melamine in food sold in Hong Kong. The purpose of this meeting was to inform the food trade the content of the legislation and to seek views on the legislation from the food trade. Details on the legislation were already announced to the public by the Secretary for Food & Health at a press conference held in the same afternoon of holding that meeting. The legislation to implement an immediate control of inappropriate level of melamine in food would be published in the gazette on 23 September 2008, i.e. the day after the meeting, and come into operation on the same day.

Current Situation on Melamine

- 3. Ms. LEUNG Yuen Sheung reported to the meeting that, pursuant to the food incidents in mainland China concerning melamine were known, actions had been taken out by the Centre for Food Safety (CFS) to monitor melamine level in food sold in Hong Kong at all levels of the food trade. Since 13 September 2008, the CFS had tested around 400 samples of dairy products that were sold in the local market. These samples were collected from all levels of the food trade, including import, wholesale and retail. The testing results of about 300 samples were known. Among these, 10 samples were found to be melamine-tainted and their particulars had also been made known to the public through press release. Testing would be continued for dairy products and extended to cover all products containing milk elements imported from countries other than mainland China as far as practicable. Full information on testing results would be announced on the web site of the CFS on a daily basis. The trade and the public were welcomed to browse the web site for the testing results.
- 4. The Chairman advised that all products with unsatisfactory testing results on samples announced by the CFS would be required to be removed from sales outlets in the local market. Products that were tested outside Hong Kong and found unsatisfactory would not be required automatically to be removed from sales outlets in the local market and the decision on whether these products should continue to be sold would be a commercial decision of the respective traders.

Control of Melamine in Food

- 5. Mr. CHAN Wai Yan briefed the meeting about the nature of melamine, the presence of melamine in food and the harmful effects of melamine on human health. As regards the control of melamine in food, Mr. CHAN Wai Yan continued that there was no specific provision in the local legislation to control melamine in food sold in Hong Kong. In light of the recent incident in mainland China over the contamination of melamine in food, Mr CHAN said the Administration proposed to control melamine by including the standards of melamine in the Harmful Substances in Food Regulations::
 - a) The maximum concentration limit of melamine in milk and food principally for the consumption of children under the age of 36 months, and pregnant and lactating women 1 milligram (mg) per kilogram (kg); and
 - b) The maximum concentration limit of melamine in other foods -2.5 mg per kg.
- 6. The Chairman assured the meeting the standards set for the control of melamine in food had already taken into account various factors including the possible residues of melamine in the food chain and manufacturing process, as well as environmental contamination. Focus was put on dairy products targeting for children under 36 months, and pregnant and lactating women in view of their high consumption of such food products and vulnerability of young children. He trusted that the proposed standards in the legislation had struck a balance between the risk posed to the public and practicability for the food trade to comply with the legislation.

Legislative Process

- 7. Mr. TSE Lai Chi informed the meeting that in view of the recent melamine incident, the Government considered necessary to introduce legislative control over inappropriate level of melamine in food urgently through amending the Harmful Substances in Food Regulations (Cap 132AF). The Amendment Regulation would be published in the gazette on 23 Sept 2008 and come into operation on the same day, and be tabled at the Legislative Council for vetting on 8 October 2008. The vetting period was 28 days from the date of meeting at which it was laid, and might be extended for 21 days subject to a resolution passed.
- 8. The Chairman summed up that melamine had aroused high and wide public interest and concerns in Hong Kong. Government was obliged to undertake prompt actions to ease public concerns and to prevent melamine-tainted food sold in Hong Kong in order to uphold food safety and protect public health in Hong Kong. He welcomed views from the food trade on the proposed controlling steps to prevent melamine in food.

Law Enforcement

9. Ms. LEUNG Yuen Sheung noted suggestions from trade representatives that Government should work closely with the authorities in mainland China to exercise control over the source of melamine in food to be exported to Hong Kong instead of simply regulating melamine in food to be sold in Hong Kong and prosecuting traders in Hong Kong. In response to trader's view that it would be difficult for them to control the source of contamination as the food production took place outside Hong Kong upon enactment of

the new legislative requirement on melamine in food, Government would consider prosecution against traders on a case-by-case basis basing on the evidence collected. Consideration would also be given whether the trader has exercised due diligence or not.

10. <u>The Chairman</u> supplemented that, in view of the urgent situation, there was no grace period for enforcing the legislation. Prosecution would only be taken out for cases where the maximum concentration limit allowed for each category of food products was exceeded. Traders were advised to try their best to comply with the legal requirements for controlling melamine in food.

Testing Method

11. Mr. LEE Foo Wing told the meeting that there was no prescribed method to be adopted in testing melamine and Government would not regulate the testing method. Traders were at liberty of selecting the appropriate testing method so long as the method was sensitive enough to detect melamine below the maximum concentration levels set out for each category of food. If prosecution action would be taken out, it would be up to the court to decide whether the testing method was appropriate for complying with the legislation.

Milk Products under the Control

12. In reply to enquiries from trade representatives, the Chairman confirmed that the relatively stricter standard of 1 mg/kg was to regulate melamine in food including all "milk" and food products principally for the consumption of children under the age of 36

months as well as those for pregnant and lactating women. The trade might refer to Section 2 "Interpretation" clause of Hong Kong Law Chapter 132 "Public Health and Municipal Services Ordinance" for the definition of "milk", namely cows milk, buffaloes milk and goats milk, and included cream and separated milk, but does not include dried milk, condensed milk or reconstituted milk. The legislation was also intended to cover milk beverages.

Supply of Milk Products

13. Mr. Owin FUNG was assured by trade representatives that the supply of infant formula milk powder and milk products would be adequate to meet the demand of the local market. Traders would closely monitor the situation and maintain a stable supply.

Responsibilities of Trade

- 14. The Chairman reminded that onus was on traders to ensure that their products sold in the market were free from melamine and other harmful substances. Government should not be held responsible for controlling the quality of individual products on behalf of traders. The testing conducted by Government was principally intended to enforce law and to ease public concerns. He recommended to the meeting that traders might wish to make known to their customers if their products were found free from melamine after testing.
- 15. <u>The Chairman</u> recommended that traders should continue to monitor the quality of their products and to comply with the legal requirements on controlling melamine in food,

including steps to control the quality of raw materials and to monitor the production process of their products, etc. He reiterated that the legislation would allow the presence of low levels of melamine in food due to environmental contamination but under no circumstances should melamine be added purposely to food.

Announcement of Testing Results

- 16. <u>The Chairman</u> said that only testing results on samples that were found exceeding the maximum concentration levels allowed by legislation were announced as unsatisfactory.
