

**Daily situation update of food surveillance on food imported from Japan**  
**(As of 31 January 2012 12 noon)**

**日本進口食物檢測每日概況**  
**(截至 2012 年 1 月 31 日 中午 12 時)**

The Centre for Food Safety (CFS) of the Food and Environmental Hygiene Department has stepped up surveillance of fresh produce imported from Japan such as milk, vegetables and fruits for examination of radiation level from 12 March 2011. The measure was taken in view of an incident involving a nuclear power plant in Japan after an earthquake.

From 16 March 2011 onwards, the CFS will update the figures of the food surveillance on the website from Monday to Friday on every working day. Results of the satisfactory samples with low radioactivity level not exceeding the guideline level of the Codex Alimentarius Commission will also be listed from 1 April 2011.

食物環境衛生署食物安全中心從 2011 年 3 月 12 日開始，因應日本發生地震後引發的核電站事故，對從日本進口本港的鮮活食品，例如牛奶、蔬菜和水果，加強監察，進行輻射水平測試。

由 2011 年 3 月 16 日開始，食物安全中心將從星期一至五，每工作天於網頁上更新該項食物監察的最新數字；並從 2011 年 4 月 1 日開始公布含低輻射量但未超出《食品法典委員會》指引限值的合格樣本結果。

\*The CFS adopts the following standards laid down by the Codex Alimentarius Commission in the Guideline Levels for Radionuclides in Foods Contaminated following a Nuclear or Radiological Emergency.

Iodine - 131 : 100Bq/kg

Caesium - 134 and Caesium - 137 : 1000Bq/kg

Food not exceeding the corresponding Guideline Levels are considered safe for human consumption.
