Statement of Purpose

(under the Personal Data (Privacy) Ordinance)

Purpose of Collection

The personal data provided will be used by this Department for controlling food safety. The provision of personal data is voluntary. Classes of Transferees

The personal data you provide are mainly for use within this Department but they may also be disclosed to other Government branches and departments or relevant parties for the purposes mentioned in para. 1 above, if required. Apart from this, the data may only be disclosed to parties where you have given consent to such disclosure or where such disclosure is allowed under the Personal Data (Privacy) Ordinance.

Access to Personal Data

3. You have a right of access and correction with respect to personal data as provided for in Sections 18 and 22 and Principle 6 of Schedule 1 of the Personal Data (Privacy) Ordinance. Your right of access included the right to obtain a copy of your personal data. A fee may be imposed for complying with a data access request.
