Preliminary investigation did not identify local sale or import of the affected products. • Acquisition of the products through online purchase or international travel cannot be excluded. • Consumers should discard the products and not consume them. • CFS will remain vigilant and monitor for any new development and take appropriate actions when necessary. • Investigation by CFS is ongoing. • Listeriosis is usually caused by eating food contaminated with Listeria which can be easily destroyed by cooking but can
