- B. Any person or company imports and/or distributes vegetables and fruits should register with the Centre for Food Safety (CFS) of their business in accordance with the Pre-Statutory Voluntary Registration Scheme.
- 丙. 分銷業務包括將進口及／或產自本港的蔬菜及／或水果分銷至其他分銷商／零售商。
- C. Distribution business includes distributing imported and / or locally produced vegetables and/or fruits to other distributors/retailers.
- 丁. 如業務只屬零售性質，則無須根據立法前自願登記計劃向中心登記。
- D. Company engaging in retail business only is not required to register with the CFS of their business under the Pre-Statutory Voluntary Registration Scheme.
- 戊. 本地農場場主如有將其農作物分銷至其他分銷商／零售商，應根據立法前自願登記計劃向中心登記為蔬菜／水果分銷商。如農作物只作零售用途，則無須根據立法前自願登記計劃向中心登記。
- E. Local farmer selling his/her produce to other distributors / retailers should register with the CFS and register as vegetables/fruits distributor under the Pre-Statutory Voluntary Registration Scheme. If the produce is for retail only, registration with the CFS is not necessary.
