Beware of the Risks Associated with Crossboundary Meals Purchased from Agents and Delivered Over Long Distance

Cross-boundary meals purchased from agents and delivered over a long distance can be risky because they may be susceptible to lapses in proper time and temperature control. potentially leading to food poisoning. Meals that need to be delivered over a long distance will be prone to spoilage during the delivery process if there is no proper control over food storage temperature and delivery time. The reminds Centre for Food Safety (CFS) consumers to be cautious and pay attention to the delivery time and temperature control of the food when ordering cross-boundary meals delivered by agents.

Most pathogenic bacteria grow and multiply rapidly at the temperature danger zone between 4°C and 60°C. To ensure food safety, hot food and cold food should be kept above 60°C and at or below 4°C respectively during the delivery process. If meals are kept within the temperature danger zone, the two-hour and four-hour principle should be followed (i.e. if prepared food is kept at room temperature for less than two hours, it can be refrigerated for later use; if cooked food has been held at room temperature for more than four hours, it should be discarded).

Consumers should order delivered meals from reliable online shops and pay attention to the types of food and the food safety risks possibly associated with them.



In addition, do not bring any game, meat, poultry or eggs into Hong Kong without health a certificate. According to the Imported Game, Meat, Poultry and Eggs Regulations (Chapter 132AK), it is an offence to bring any game, meat, poultry or eggs into Hong Kong without a health certificate issued by an issuing entity of the place of origin and/or without prior written permission granted by the Food and Environmental Hygiene Department.
