# Labelling of Prepackaged Food in Hong Kong

#### **Centre for Food Safety**





Nutrition labelling regulations cover the prepackaged food.

 "Prepackaged food" means any food packaged, whether completely or partially,

in such a way that

 the contents cannot be altered without opening or changing the packaging; and

the food is ready for presentation to the ultimate consumer or a catering establishment as a single food item.





The following are not considered as prepackaged food and general labelling and nutrition labelling is not required:

 Products that are not packed beforehand and are just put in packaging for customers at the point of sale

Not prepackaged food

 Products put in packaging that the opening is not tied up nor sealed

However, for example, for bakery products packed in a plastic bag fastened up with a metal wire, a plastic wire or a date hook, they are considered as prepackaged food.







# Labelling of Prepackaged Food in Hong Kong

- At present, Cap. 132 W requires the following information to be legibly marked on the food label of all prepackaged food, unless otherwise exempted-
- 1. Name of the food;
- List of ingredients (including ingredients, allergenic substances and additives);
- Indication of durability;
- 4. Special conditions for storage or instruction for use;
- Count, weight or volume;
- Name and address of manufacturer or packer; andNutrition label.

### **Food Labelling**

#### 食物名稱 Name of the food

- 須加上可閱標記,不得就食物的性質有虛假、誤導或詐騙成分。
- It shall be legibly marked and shall not be false, misleading or deceptive as to the nature of the food.

Name and address of manufacturer or packer

- "此日期或之前食用"或"此日期前最佳"
- . "Use by" or "Best before" date.



#### 配料表 List of ingredients

- 配料須按用於食物包裝時所 佔的重量或體積,由大至小 依次表列。
- 如含有法例中列明的食物致 敏物,必須標示。
- 如使用添加劑,須標示其作用 類別和其本身所用名稱或國際 識別編號(不論是否以"E"或 "e"為詞頭)。
- Ingredients should be listed in descending order of weight or volume determined as at the time of their use when the food was packaged.
- Allergenic substances stated in the law should be specified if they are present in the food.
- Functional class of an additive and its specific name or international identification number (with or without the prefix "E" or "e") should be specified if it is used.

#### 1. Name of the Food

The food name shall not be false, misleading or deceptive. It should also serve to make the nature and type of food known to the purchaser.





### 2. List of Ingredients

- Preceded by an appropriate heading consisting of the words "ingredients", "composition", "contents" or words of similar meaning, the ingredients shall be listed in descending order of weight or volume determined as at the time of their use when the food was packaged
- Declare the presence of any of the eight substances, namely
  - cereals containing gluten;
  - crustacea and crustacean products;
  - 3. eggs and egg products;
  - 4. fish and fish products;
  - 5. peanuts, soybeans and their products;
  - 6. milk and milk products (lactose included);
  - 7. tree nuts and nut products; and
  - 8. sulphite in concentrations of 10 parts per million or more, which are known to cause allergy.

If an additive constitutes one of the ingredients of a food, it should be listed by both the **functional class** and the **specific name** or the identification number under the International Numbering System for Food Additives adopted by the Codex Alimentarius Commission **\*\* \*\* \*\* \*\* \*\* \*\* \*\*** 

### 3. Indication Durability

- Use either the words
- "use by 此日期或之前食用" or
- "best before 此日期前最佳", as the case may be, followed by the date up to which specific properties of the food can be retained, to indicate the shelf life of the food.





# 4. Statement of Special Conditions for Storage or Instructions for Use

If special conditions are required for storage to retain the quality or special instructions are needed for the use of prepackaged food, a statement should be legibly marked on the label.





# 5. Name and Address of Manufacturer or Packer

The prepackaged food should be legibly labelled with the full name and full address of the manufacturer or packer, or otherwise in accordance with the requirements as stipulated in the Regulations.





# 6. Count, Weight or Volume of Food

 The food label should include the numerical count or net weight or net volume of the prepackaged food.





### **Food Labelling**

- Save with the exemptions for those items as listed in Schedule 4 to the Food and Drugs (Composition and Labelling) Regulations (Cap. 132W), it is in breach of regulation 4 or 4A of the said Regulations.
- If there is sufficient evidence to prove any contravention under the Food and Drugs (Composition and Labelling) Regulations (Cap. 132W), legal action will be taken against the offender. Upon conviction by the Court, the offender is liable to a maximum fine of \$50,000 and 6 months imprisonment.

#### Aims of the Scheme

- Facilitate consumers in making healthy food choices
- Encourage food manufacturers to apply sound nutrition principles in the formulation of foods
- Regulate misleading or deceptive labels and claims on nutrition information

# The scope of nutrition labelling scheme

Any person who sells prepackaged food without nutrition labelling is liable to a maximum fine of \$ 50,000 and imprisonment for 6 months.





# Required Nutrients on Nutrition Labels

- 1+7 (energy +7 core nutrients) i.e., energy, protein, carbohydrate\*, total fat, saturated fat, trans fat, sodium, sugars
- Claimed nutrients

   (when the claim is on any type of fat, cholesterol content must be declared as well)
- For other nutrients,declaration is voluntary





# Required Nutrients on NL - Expressions

- Per 100 g (or 100 ml);
- Per package (if the package contains only one single serving); or
- Per serving (if the information on the serving size in g/ml and the no. of servings in the package are provided)

#### **Nutrition Claim**

- Means any representation
   which states, suggests or
   implies that a food has
   particular nutritional properties
- Nutrition claims include:
  - Nutrient content claim
  - Nutrient comparative claim
  - Nutrient function claim
- Food labels and
  - advertisement are subject to the control







### **Exemptions- Principles**

- As for nutrition labelling, under Schedule 6 of Cap.132W, some food items are exempted from the nutrition labelling requirements of the Regulations,
- General Exemption Item
  - Practical difficulty for the trade (e.g., prepackaged food packed in a container which has a total surface area of less than 100cm<sup>2</sup>)
  - The food does not contain (meeting definition of zero) of energy and core nutrients
  - Certain food which is fresh in nature without any addition
     of ingredient (e.g., fresh and dried fruits and vegetables)

# Small Volume Exemption Scheme

- Prepackaged foods
  - same version
  - with annual sales volume not exceeding 30,000 units
  - may be granted with exemption from providing nutrition labelling.
- Prior approval from Centre for Food Safety (CFS) of FEHD is required.





### **Eligible Applicants**

- Importers (for imported products)
   Manufacturers (for local products)
- Must be a Hong Kong registered company (holding a valid Business Registration Certificate (BRC))
- In case applying in the name of individual, the applicant must hold a Hong Kong Identity Card (HKIC)
- For the same product, we can accept applications from more than one importer or manufacturer





# **Label for Exempted Product**

The exempted product, when displayed for sale, should bear a label/sticker printed with the following wordings:

### **Label for Exempted Product**

The Exemption no. may also marked legibly on a conspicuous place close to where the product is displayed for sale (like the display card for price in the product shelf).
