背景

Background

- □ 立法會已於2014年10 月完成《2014年食物 及藥物(成分組合及標 籤)(修訂)(第2號)規例》 的審議程序。
- □ 有關《規例》規管嬰兒 配方產品的營養成分組 合、以及嬰兒配方產品、 較大嬰兒及幼兒配方產 品及預先包裝嬰幼兒食 物的營養標籤。
- The Legislative Council has completed its vetting of the Food and Drugs (Composition and Labelling) (Amendment) (No. 2) Regulation 2014 in October 2014.
- The Regulation comprises requirements on nutritional composition of infant formulae and nutrition labelling of infant formulae, follow-up formulae and prepackaged food for infants and young children.

- 較大嬰兒及幼兒配方產品及 預先包裝嬰幼兒食物的營養 標籤規定將於兩年寬限期後 ,即二零一六年六月十三日 起實施。
- The requirements on nutritional composition and nutrition labelling of infant formulae came into operation on 13 December 2015.
- The requirements on nutrition labelling of follow-up formulae and prepackaged food for infants and young children will come into operation on 13 June 2016 after a two-year grace period.

- Follow-up formula must label the energy value and content of 25 nutrients (i.e. "1+25")





Nutrition labelling requirement for follow-up formula (2)

- 1+25) -
 - 能量

 - 9 種礦物質 (鐵、鈣、磷、鎂 、鈉、氯化物、鉀、碘、鋅)

- 1 (1+25) -
 - Energy
 - Protein
 - Carbohydrates
 - Total fat
 - 13 Vitamins (A, D, E, K, thiamine, riboflavin, niacin, B6, B12, pantothenic acid, folic acid, C, biotin)
 - 9 Minerals (Fe, Ca, P, Mg, Na, Cl, K, I, Zn)

Nutrition labelling requirement for prepackaged foods for infants and young children

- □ 預先包裝嬰幼兒食物 的標籤須標示
 - 能量值
 - 蛋白質、總脂肪、 碳水化合物及鈉的 含量
 - 維他命A和D(如有 加入的話)的含量

- Prepackaged foods for infants and young children must label
 - the energy value
 - the contents of protein, total fat, carbohydrates and sodium
 - the contents of vitamin A and vitamin D if they are added to the food

Exemption for Formula for special medical purposes for infants and young children

- □ 特殊醫用嬰幼兒配方產 品如按《修訂規例》加 上特定標籤,可獲豁免 遵從
 - 營養成分組合規定
 - 營養標籤規定

- redical purposes for infants and young children (FSMP) marked or labelled with required information will be exempted from the requirements of
 - nutritional composition
 - nutrition labelling





其他豁免項目 Other Exemptions

- 嬰兒配方產品及較大嬰兒及幼兒配方產品如包裝在總表面面積小於250平方厘米的容器內,可獲豁免遵從營養標籤規定
- □ 預先包裝嬰幼兒食物如 包裝在總表面面積小於 100平方厘米的容器內 ,可獲豁免遵從營養標 籤規定
- Infant formula and follow-up formula packed in a container with a total surface area of less than 250 cm² will be exempted from the nutrition labelling requirements
- Prepackaged food for infants and young children packed in a container with a total surface area of less than 100 cm² will be exempted from the nutrition labelling requirements

Regulation for Formula Products and Foods for Infants and Young Children

Food and Drugs (Composition and Labelling) (Amendment) (No. 2) Regulation 2014

The Legislative Council has completed its vetting of the Food and Drugs (Composition and Labelling) (Amendment) (No. 2) Regulation 2014 in October 2014. The Regulation comprises requirements on nutritional composition of infant formulae and nutrition labelling of infant formulae, follow-up formulae and prepackaged food for infants and young children. The requirements on nutritional composition and nutrition labelling of infant formulae will come into operation on 13 December 2015 after a 18-month grace period. The requirements on nutrition labelling of follow-up formulae and prepackaged food for infants and young children will come into operation on 13 June 2016 after a two-year grace period.
