### Remarks

- ✧ 參與論壇的人士必須為食物業界/食物業協會/機構/公司或與食物有關的協會/機構/公司。不符合上述資格及沒有提供咭片的人士，食物安全中心將不會讓其參與論壇。
- ✧ The forum is only open to representatives from food trade/food trade association/organization/company or food related association/organization/company. The Centre for Food Safety will refuse admission to any individual who is ineligible and cannot provide a business card.
- ✧ 由於座位有限，每個食物業機構/公司可於報名表內提名一位代表參加。座位會根據先到先得的原則安排，額滿即止。如報名一經接受，本署將另行通知。
- ✧ Due to limited seating capacity, each food trade organization/company may nominate **ONE** representative in the enrolment form. Seats would be assigned on a **first-come-first-served basis and successful enrollment will be notified separately.**

### Typhoon and Adverse Weather Arrangement

- If the Hong Kong Observatory still holds Tropical Cyclone Warning Signal No. 8 or above or Black Rainstorm Warning Signal or “extreme conditions” 4 hours before the start of the forum, the forum will be cancelled.
- The Tropical Cyclone Warning Signal No. 8 or above or Black Rainstorm Warning Signal or “extreme conditions” is issued (or will be issued) 2 hours before the forum starts, the forum will also be cancelled.
- If the Hong Kong Observatory issues a forecast or hoists Typhoon Signal No. 8 or above during the forum, the forum will be cancelled immediately.
- If the black rainstorm warning signal is hoisted by the Hong Kong Observatory during the forum, the forum will continue.

### 颱風及惡劣天氣安排

- 若香港天文台於論壇開始前4小時仍然維持八號或以上熱帶氣旋警告訊號或黑色暴雨警告信號或“極端情況”，論壇將會取消。
- 若於論壇開始前2小時，發出(或將發出)八號或以上熱帶氣旋警告訊號或黑色暴雨警告信號或“極端情況”，論壇亦將會取消。
- 若香港天文台於論壇期間預告或懸掛八號或以上颱風訊號，論壇將立刻取消。
- 若香港天文台於論壇期間懸掛黑色暴雨警告，論壇將繼續進行。
