- 若於工作坊開始前2小時,即下午1時,發出(或將發出)八號或以上熱帶氣旋警告信號或黑色暴雨警告信號,工作坊亦將會取消。
- 若香港天文台於工作坊期間發出預告或懸掛八號或以上颱風訊號,工作坊將立刻取消。
- 若香港天文台於工作坊期間懸掛黑色暴雨警告,工作坊將繼續進行。

#### Typhoon and Adverse Weather Arrangements:

- If Tropical Cyclone Warning Signal No.8 or above OR Black Rainstorm Warning Signal has been hoisted and is still being hoisted by the Hong Kong Observatory 4 hours before the workshop starting time (i.e. 11:00 am), the workshop will be cancelled.
- The workshop will also be cancelled if Tropical Cyclone Warning Signal No. 8 or above OR Black Rainstorm Warning Signal is hoisted (or to be hoisted) 2 hours before the workshop starting time (i.e. 1:00 pm).
- If the Hong Kong Observatory issues the Pre-No. 8 Announcement or the Tropical Cyclone Warning Signal No. 8 or above is hoisted during the event, the workshop will be terminated immediately.
- If the Hong Kong Observatory announces that the black rainstorm warning is to be hoisted or is hoisted during the workshop, programmes already in progress will continue.
