Position of CFS		<ul style="list-style-type: none">The Centre for Food Safety (CFS) is investigating whether the affected products have been imported to Hong Kong and is contacting the relevant authority for further information.Preliminary follow-up with Danone Nutricia Early Life Nutrition (Hong Kong) Limited, local importers and major retailers did not identify local sale or import of the affected products.Acquisition of the products through online purchase or international travel cannot be excluded.Consumers should discard the products and not consume them.CFS will remain vigilant and monitor for any new development and take appropriate actions when necessary.Investigation by CFS is ongoing.<i>Bacillus cereus</i> is commonly found in the environment. Unhygienic conditions in food processing and storage may give rise to its growth. Consuming food contaminated with excessive <i>Bacillus cereus</i> or its heat-stable toxins may cause gastrointestinal upset such as vomiting and diarrhoea.
