

# 食物環境衛生署 機場辦事處

## Food and Environmental Hygiene Department Airport Offices



### 簡介

食物環境衛生署機場辦事處設於大嶼山赤鱗角香港國際機場的三處地方：

- 香港空運貨站公司超級一號貨站辦公大樓南座一樓及四樓；
- 亞洲空運中心二號空運貨站一樓；
- 國泰航空貨運站東南座地下。

除辦公室外，上述三個空運貨站內的辦事處內還設有食物檢查室、冷凍及冷藏設備，以配合食物檢驗工作。

辦事處現有人手編制50多人，每天24小時分三班工作；其中包括24名衛生督察負責執行食物檢驗及食物衛生安全法例的工作。

### 職能

機場食物檢驗辦事處的工作目標是確保經空運進口香港的食物適宜供人食用。

### 工作範圍

#### 查核文件

當食物空運到港並從飛機卸下到貨站後，衛生督察便會檢查進口商所提交的文件是否齊備；文件包括空運提貨單、貨物清單、衛生證明書、進口證、進口准許書、瀕危野生動植物種國際貿易公約證書等。



### 檢驗食物及抽取樣本

衛生督察會檢查空運到港的食物，以及抽取樣本作微生物檢驗、化學分析及輻射水平檢測。屬容易變壞及高風險性質的食物，如肉類、家禽、蛋類、野味、奶類、奶類飲品、冰凍甜點和海產等，衛生督察均會加強檢查。食物環境衛生署亦會視乎情況扣留某些食物，待檢查及檢驗/分析/檢測的結果滿意後才將食物放行。

### 禁止攜帶未經批准的野味、肉類、家禽及蛋類入境

法例規定，任何人士未有書面批准及/或衛生證明書而攜帶野味、肉類、家禽或蛋類入境，即屬違法；一經定罪，可被罰款及監禁。在機場值班的衛生督察，會對非法攜帶上述食物入境的旅客採取檢控行動。

## Introduction

The Airport Offices of the Food and Environmental Hygiene Department (FEHD) comprises three different working locations at the Hong Kong International Airport in Chek Lap Kok on Lantau Island –

- Level 1 & Level 4, South Office Block, Super Terminal 1, HACTL;
- 1/F, Terminal 2, Asia Airfreight Terminal;
- G/F, Core SE, Cathay Pacific Cargo Terminal.

In addition to the availability of offices, there are also food inspection rooms and cold storage facilities for the above three offices at the air cargo terminals in order to cope with the food inspection work.

Operating 24 hours a day, the Offices have an establishment of some 50 staff, working on 3 shifts. They include 24 Health Inspectors responsible for carrying out food inspection and enforcing legislation pertaining to food safety.



## Responsibilities

The objective of the Airport Offices is to ensure that all foods imported into Hong Kong by air are fit for human consumption.

### Areas of Work

#### Verification of Documents

When the food has arrived in Hong Kong by air and unloaded, Health Inspectors will check whether the importer has submitted all necessary documents which include air waybills, packing lists, health certificates, import licences, permission letters, CITES (Convention on International Trade in Endangered Species of Wild Fauna and Flora) licences/permits, etc.

#### Inspection and Sampling of Food

Health Inspectors will inspect the food imported into Hong Kong by air and take samples for microbiological examination, chemical analysis and radiation level test. For perishable and high-risk food items such as game, meat, poultry, eggs, milk, milk beverages, frozen confections and marine products, Health Inspectors will step up inspections and sampling. If circumstances warrant, FEHD will detain the food item and will only release it if inspection and examination / analysis / test results are satisfactory.



### Safeguards against Unauthorised Entry of Hand-carried Game, Meat, Poultry and Eggs

According to the law, any person who brings game, meat, poultry or eggs into Hong Kong without permission in writing and/or a health certificate commits an offence and shall be liable to a fine and imprisonment if convicted. Health Inspectors at the airport will prosecute travellers who bring in any of such food illegally.
